

THUMBPRINT Signature Program



The Thumbprint Signature Program helps deter check fraud by taking a thumbprint signature from non-customers who are cashing checks. The program is an inexpensive way to prevent fraud without inconveniencing customers and also dramatically speeds up the law enforcement investigation process.

Touch Pads are two-inch, inkless printing devices that leave no residue on the finger when used. Pads use black ink and have a shelf life of up to 18 months or will produce 400 to 600 impressions.

Teller Window Displays are "tent-style," 6"x3" displays for posting at all teller windows as an additional reminder that the institution is a participant in the program.

Statement Stuffers (English/Spanish) are two-sided, 3²/₃"x8¹/₂" single sheets explaining the program. Distribute the stuffers to account holders and have enough available for anyone with questions about the program. Order in increments of 500.

Decals are round, four-inch, self-adhesive decals for posting at entrances and drive-ups that announce participation in the program and warn potential criminals that their crimes will not go undetected.
