FIPCO HARD COPY FORMS NOTICE

Please note: This notice is not a comprehensive review of the changes made to the revised form. Refer to the instructions and supplemental instructions prepared for the form for details and further review of the form.

The following form is available immediately from FIPCO:

New Commercial Form

WBA 448RT Revolving and Term Credit Agreement (8/13/07). This is a new form which includes features of both the WBA term and revolving credit agreements with the same covenants for each. It can be used to evidence a term loan consisting of either a single note with multiple advances or multiple notes with multiple advances and/or a revolving loan.

Whether used for term or revolving credit transactions, this is a relatively complete loan agreement which should accommodate many loan transactions. The basic agreement may be expanded to include additional provisions by attaching exhibits to the agreement. The WBA has prepared standard exhibit forms (Business WBA 448RTA, RTB, RTC and RTD) which may be used by the lender.

The agreement may be used to evidence business, commercial or agricultural loans made under Wisconsin law, but may not be used to evidence consumer loans.

Lenders may begin using this new form at their earliest convenience.
